**ORDINANCE NO. \_\_\_\_\_, SERIES 2017**

**AN ORDINANCE APPROPRIATING ~~\$10,000~~ \$11,000 \$12,000 FROM NEIGHBORHOOD DEVELOPMENT FUNDS IN THE FOLLOWING MANNER: \$5,000 FROM DISTRICT 1; \$1,500 FROM DISTRICT 3; AND \$500 EACH FROM DISTRICTS 2, 4, 5, 6, 7, 9, 10, 13, AND 15, AND 21 AND 25; THROUGH THE OFFICE OF MANAGEMENT AND BUDGET, TO LEGAL AID SOCIETY, INC. FOR COSTS ASSOCIATED WITH PROVIDING EXPUNGEMENT SERVICES IN ITS EMPLOYMENT OPPORTUNITY PROGRAM. (AS AMENDED).**

**BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:**

**SECTION I:** The sum of ~~\$40,000~~ \$11,000 \$12,000 is hereby appropriated from Neighborhood Development Funds in the following manner: \$5,000 from District 1; \$1,500 from District 3; and \$500 each from Districts 2, 4, 5, 6, 7, 9, 10, 13, and 15, and 21 and 25; through the Office of Management and Budget, to Legal Aid Society, Inc. for costs associated with providing expungement services in its Employment Opportunity Program.

**SECTION II:** The Council has determined the funds requested in this Ordinance will be expended for a public purpose.

**SECTION III:** This grant is subject to the Council's Policies and Procedures as adopted and effective at the date of passage of this Ordinance.

**SECTION IV:** This Ordinance shall take effect upon its passage and approval.
