ORDINANCE NO. _____, SERIES 2017

AN ORDINANCE APPROPRIATING ~~\$10,000~~ \$11,000 \$12,000 FROM NEIGHBORHOOD DEVELOPMENT FUNDS IN THE FOLLOWING MANNER: \$5,000 FROM DISTRICT 1; \$1,500 FROM DISTRICT 3; AND \$500 EACH FROM DISTRICTS 2, 4, 5, 6, 7, 9, 10, 13, AND 15, AND 21 AND 25; THROUGH THE OFFICE OF MANAGEMENT AND BUDGET, TO LEGAL AID SOCIETY, INC. FOR COSTS ASSOCIATED WITH PROVIDING EXPUNGEMENT SERVICES IN ITS EMPLOYMENT OPPORTUNITY PROGRAM. (AS AMENDED).

BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:

SECTION I: The sum of ~~\$40,000~~ \$11,000 \$12,000 is hereby appropriated from Neighborhood Development Funds in the following manner: \$5,000 from District 1; \$1,500 from District 3; and \$500 each from Districts 2, 4, 5, 6, 7, 9, 10, 13, and 15, and 21 and 25; through the Office of Management and Budget, to Legal Aid Society, Inc. for costs associated with providing expungement services in its Employment Opportunity Program.

SECTION II: The Council has determined the funds requested in this Ordinance will be expended for a public purpose.

SECTION III: This grant is subject to the Council's Policies and Procedures as adopted and effective at the date of passage of this Ordinance.

SECTION IV: This Ordinance shall take effect upon its passage and approval.
