ORDINANCE NO. _____, SERIES 2018

AN ORDINANCE APPROPRIATING ~~\$8,500~~\$10,200 FROM NEIGHBORHOOD DEVELOPMENT FUNDS IN THE FOLLOWING MANNER: \$1,000 EACH FROM DISTRICTS 14, 1, 6, 7, 12, 13, 15, 21, AND 25; \$500 EACH FROM DISTRICTS 3 AND 5; AND \$200 FROM DISTRICT 23; THROUGH THE OFFICE OF MANAGEMENT AND BUDGET, TO RIVERSIDE, THE FARNSLEY-MOREMEN LANDING, INC. FOR SPONSORSHIP OF THE 15TH ANNUAL "MAYOR'S DERBY BRUNCH ON THE RIVER" EVENT. (AS AMENDED).

BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE "COUNCIL") AS FOLLOWS:

SECTION I: The sum of ~~\$8,500~~\$10,200 is hereby appropriated from Neighborhood Development Funds in the following manner: \$1,000 each from Districts 14, 1, 6, 7, 12, 13, 15, 21, and 25; and \$500 each from Districts 3 and 5; and \$200 from District 23; through the Office of Management and Budget, to Riverside, The Farnsley-Moremen Landing, Inc. for sponsorship of the 15th annual "Mayor's Derby Brunch on the River" event.

SECTION II: The Council has determined the funds requested in this Ordinance will be expended for a public purpose.

SECTION III: This grant is subject to the Council's Policies and Procedures as adopted and effective at the date of passage of this Ordinance.

SECTION IV: This Ordinance shall take effect upon its passage and approval.
