### ORDINANCE NO. \_\_\_\_\_, SERIES 2019

**AN ORDINANCE APPROPRIATING ~~\$5,450~~ \$7,700 FROM NEIGHBORHOOD DEVELOPMENT FUNDS IN THE FOLLOWING MANNER: \$2,000 FROM DISTRICT 21; \$1,000 FROM DISTRICT 9; \$500 EACH FROM DISTRICTS 6, 12, AND 13, AND 14; \$450 FROM DISTRICT 10; AND \$250 EACH FROM DISTRICTS 1, 2, 3, 15, AND 17, 20, 22, 25, AND 26; THROUGH THE OFFICE OF MANAGEMENT AND BUDGET, TO AMERICANA COMMUNITY CENTER, INC. FOR OPERATING EXPENSES (AS AMENDED).**

**BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:**

**SECTION I:** The amount of ~~\$5,450~~ \$7,700 is hereby appropriated from Neighborhood Development Funds in the following manner: \$2,000 from District 21; \$1,000 from District 9; \$500 each from Districts 6, 12, and 13, and 14; \$450 from District 10; and \$250 each from Districts 1, 2, 3, 15, and 17, 20, 22, 25, and 26; through the Office of Management and Budget, to Americana Community Center, Inc. for operating expenses.

**SECTION II:** The Council has determined the funds requested in this Ordinance will be expended for a public purpose.

**SECTION III:** This grant is subject to the Council's Policies and Procedures as adopted and effective at the date of passage of this Ordinance.

**SECTION IV:** This Ordinance shall take effect upon its passage and approval.
