**ORDINANCE NO. \_\_\_\_\_, SERIES 2019**  
**AN ORDINANCE APPROPRIATING ~~\$7,000~~ \$8,750 ~~\$11,000~~ FROM NEIGHBORHOOD DEVELOPMENT FUNDS IN THE FOLLOWING MANNER: \$4,000 FROM DISTRICT 15; AND \$1,000 EACH FROM DISTRICTS 12, 13, 14, 21, AND 25; \$500 FROM DISTRICT 23; AND \$250 EACH FROM DISTRICTS 2, 3, 6, 8, 17, AND 24; TO LOUISVILLE METRO PARKS DEPARTMENT FOR PROGRAMMING COSTS ASSOCIATED WITH THE 2019 SERIES OF MOVIES, ART EVENTS, FESTIVALS, AND OTHER FREE AND LOW COST EVENTS OPEN TO THE PUBLIC AT IROQUOIS PARK AMPHITHEATER (AS AMENDED).**

**BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:**

**SECTION I:** The sum of ~~\$7,000~~ \$8,750 ~~\$11,000~~ is hereby appropriated from Neighborhood Development Funds in the following manner: \$4,000 from District 15; and \$1,000 each from Districts 12, 13, 14, 21, and 25; \$500 from District 23; and \$250 each from Districts 2, 3, 6, 8, 17, and 24; to Louisville Metro Parks Department for programming costs associated with the 2019 series of movies, concerts, art events, festivals, and other free and low cost events open to the public at Iroquois Park Amphitheater.

**SECTION II:** The Council has determined the funds requested in this Ordinance will be expended for a public purpose.

**SECTION III:** This grant is subject to the Council's Policies and Procedures as adopted and effective at the date of passage of this Ordinance.

**SECTION IV:** This Ordinance shall take effect upon its passage and approval.
