**AN ORDINANCE APPROPRIATING ~~\$10,950~~ \$12,450 ~~\$19,200~~ FROM NEIGHBORHOOD DEVELOPMENT FUNDS IN THE FOLLOWING MANNER: \$3000 FROM DISTRICT 3; \$2,500 FROM DISTRICT 20; \$2,000 EACH FROM DISTRICTS 3, 1, 20, 21; \$1,000 EACH FROM DISTRICTS 2 AND 25; \$750 FROM DISTRICT 5; \$700 FROM DISTRICT 6; \$500 EACH FROM DISTRICTS 5, 8, 9, 10, 11, 12, 16, 17, AND 22, 23, 24, AND 26 AND \$250 EACH FROM DISTRICTS 7, 10, 13 AND 15; THROUGH THE OFFICE OF MANAGEMENT AND BUDGET, TO UNITED NATIONS ASSOCIATION OF THE UNITED STATES OF AMERICA KENTUCKY DIVISION, LTD. FOR PROGRAMMING EXPENSES ASSOCIATED WITH CONDUCTING THE HUMAN TRAFFICKING CONFERENCE: LOCAL TO GLOBAL (AS AMENDED)**

**BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:**

**SECTION I:** The sum of ~~\$10,950~~ \$12,450 ~~\$19,200~~ is hereby appropriated from the Neighborhood Development Funds in the following manner: \$3,000 from District 3; \$2,500 from District 20; \$2,000 each from Districts 3, 1, 20, 21; \$1,000 each from Districts 2 and 25; \$750 from District 5; \$700 from District 6; \$500 each from Districts 5, 8, 9, 10, 11, 12, 16, 17, and 22, 23, 24, and 26 and \$250 each from Districts 7, 10, 13 and 15; through the Office of Management and Budget, to United Nations Association of the United States of America Kentucky Division, Ltd. For programming expenses associated with conducting the Human Trafficking Conference: Local to Global.

**SECTION II:** The Council has determined the funds requested in this Ordinance will be expended for a public purpose.

**SECTION III:** This grant is subject to the Council's Policies and Procedures as adopted and effective at the date of passage of this Ordinance.

**SECTION IV:** This Ordinance shall take effect upon its passage and approval.
