AN ORDINANCE APPROPRIATING ~~\$30,400~~ \$43,200 ~~\$54,400~~ IN NEIGHBORHOOD DEVELOPMENT FUNDS IN THE FOLLOWING MANNER: \$8,000 EACH FROM DISTRICTS 4 AND 23; \$6,400 EACH FROM DISTRICTS 2 AND 24; \$4,800 EACH FROM DISTRICTS 12 AND 17; \$3,200 EACH FROM DISTRICTS 7, 10, AND 11; AND \$1,600 EACH FROM DISTRICTS 1, 6, 9, AND 21; THROUGH THE OFFICE OF MANAGEMENT AND BUDGET, TO COMMONWEALTH THEATRE CENTER, INC. TO FUND THE PRESENTATION OF "RUMPELSTILTSKIN" AT SCHOOLS THROUGHOUT JEFFERSON COUNTY (AS AMENDED).

BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:

SECTION I: The sum of ~~\$30,400~~ \$43,200 ~~\$54,400~~ from Neighborhood Development Funds in the following manner: \$8,000 each from Districts 4 and 23; \$6,400 each from Districts 2 and 24; \$4,800 each from Districts 12 and 17; \$3,200 each from Districts 7, 10, and 11; and \$1,600 each from Districts 1, 6, 9, and 21; through the Office of Management and Budget, to Commonwealth Theatre Center, Inc., for programming expenses associated with performances of "Rumpelstiltskin."

SECTION II: The Council has determined the funds requested in this Ordinance will be expended for a public purpose.

SECTION III: This grant is subject to the Council's Policies and Procedures as adopted and effective at the date of passage of this Ordinance.

SECTION IV: This Ordinance shall take effect upon its passage and approval.
