**ORDINANCE NO. \_\_\_\_\_, SERIES 2022**

**AN ORDINANCE APPROPRIATING ~~\$3,000~~ \$5,500 \$9,200 FROM NEIGHBORHOOD DEVELOPMENT FUNDS IN THE FOLLOWING MANNER: \$3,000 FROM DISTRICT 21 NEIGHBORHOOD DEVELOPMENT FUNDS,; \$1,000 EACH FROM DISTRICTS 13, AND 15, AND 24; \$950 FROM DISTRICT 25; AND \$500 EACH FROM DISTRICTS 3, 4, 10, AND 22; AND \$250 FROM DISTRICT 17; THROUGH THE OFFICE OF MANAGEMENT AND BUDGET, TO SOUTH LOUISVILLE COMMUNITY MINISTRIES (“SLCM”) FOR THE ANNUAL FAMILIES HELPING FAMILIES DINNER SUPPORTING SLCM’S EMERGENCY RENTAL ASSISTANCE AND PROGRAMMING (AMENDMENT BY SUBSTITUTION)(AS AMENDED).**

**SPONSORED BY: COUNCIL MEMBERS GEORGE, FOX, TRIPLETT, MULVIHILL, FLOOD, HOLTON STEWART, DORSEY, ENGEL, ARTHUR, AND WINKLER**

**BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE “COUNCIL”) AS FOLLOWS:**

**SECTION I:** The sum of ~~\$3,000~~ \$5,500 \$9,200 is hereby appropriated from Neighborhood Development Funds in the following manner: \$3,000 from District 21 Neighborhood Development Funds,; \$1,000 each from Districts 13, and 15, and 24; \$950 from District 25; and \$500 each from Districts 3, 4, 10, and 22; and \$250 from District 17; through the Office of Management and Budget, to SLCM to fund the annual Families Helping Families Dinner supporting SLCM’s emergency rental assistance and programming.

**SECTION II:** The Council has determined the funds requested in this Ordinance will be expended for a public purpose.

**SECTION III:** This grant is subject to the Council’s Policies and Procedures as adopted and effective at the date of passage of this Ordinance.

**SECTION IV:** This Ordinance shall take effect upon its passage and approval or otherwise becoming law.
