ORDINANCE NO. _____, SERIES 2020

AN ORDINANCE APPROPRIATING ~~\$25,000~~ \$27,500 ~~\$35,000~~ FROM DISTRICT 23 NEIGHBORHOOD DEVELOPMENT FUNDS IN THE FOLLOWING MANNER: \$25,000 FROM DISTRICT 23; \$3,250 FROM DISTRICT 7; \$2,000 FROM DISTRICT 24; \$1,000 EACH FROM DISTRICTS 2, 4, AND 13; \$750 FROM DISTRICT 15; AND \$500 EACH FROM DISTRICTS 21 AND 22; THROUGH THE OFFICE OF MANAGEMENT AND BUDGET, TO FUND FOR THE ARTS, INC. TO CREATE A COMMUNITY THEATER AND ARTS SPACE IN A VACANT STORE FRONT IN OUTER LOOP PLAZA (AS AMENDED).

BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:

SECTION I: The sum of ~~\$25,000~~ \$27,500 ~~\$35,000~~ is hereby appropriated from District 23 Neighborhood Development Funds in the following manner: \$25,000 from District 23; \$3,250 from District 7; \$2,000 from District 24; \$1,000 each from Districts 2, 4, and 13; \$750 from District 15; and \$500 each from Districts 21 and 22; through the Office of Management and Budget, to Fund for the Arts, Inc. to create a community theater and arts space in a vacant store front in Outer Loop Plaza.

SECTION II: The Council has determined the funds requested in this Ordinance will be expended for a public purpose.

SECTION III: This grant is subject to the Council's Policies and Procedures as adopted and effective at the date of passage of this Ordinance.

SECTION IV: This Ordinance shall take effect upon its passage and approval.
