AN ORDINANCE APPROPRIATING ~~\$13,500~~ \$14,500 FROM NEIGHBORHOOD DEVELOPMENT FUNDS IN THE FOLLOWING MANNER: \$5,000 FROM DISTRICT 13; \$2,250 FROM DISTRICT 14; \$1,000 FROM DISTRICTS 12, 15, 23, AND 25; \$500 FROM DISTRICTS 1, 10, 21, AND 22, AND 24; \$250 FROM DISTRICTS 8, 9, AND 17, TO THE LOUISVILLE METRO PARKS DEPARTMENT FOR THE 2020 ANNUAL FOREST FEST BLUEGRASS MUSIC FESTIVAL TO BE HELD AT THE JEFFERSON MEMORIAL FOREST ON ~~MAY 16, 2020~~ IN OCTOBER 2020 (AS AMENDED).

BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE "COUNCIL") AS FOLLOWS:

SECTION I: The sum of ~~\$13,500~~ \$14,500 is hereby appropriated from Neighborhood Development Funds in the following manner: \$5,000 from District 13; \$2,250 from District 14; \$1,000 from Districts 12, 15, 23, and 25; \$500 from Districts 1, 10, 21, and 22, and 24; \$250 from Districts 8, 9, and 17, to the Louisville Metro Parks Department for the 2020 Annual Forest Fest Bluegrass Music Festival to be held at the Jefferson Memorial Forest.

SECTION II: The Council has determined the funds requested in this Ordinance will be expended for a public purpose.

SECTION III: This grant is subject to the Council's Policies and Procedures as adopted and effective at the date of passage of this Ordinance.

SECTION IV: This Ordinance shall take effect upon its passage and approval.
