AN ORDINANCE APPROPRIATING ~~\$5,000.04~~ \$10,750 \$15,250 FROM DISTRICT NEIGHBORHOOD DEVELOPMENT FUNDS AS FOLLOWS: ~~\$5,000.04~~ \$5,000 FROM DISTRICT 14; \$1,000 EACH FROM DISTRICTS 13, 15, 12, 10; 24, 25; \$500 EACH FROM DISTRICTS 9, 16 2, 3, 6, 7, 17; \$750 FROM DISTRICT 8; THROUGH THE OFFICE OF MANAGEMENT AND BUDGET, TO THE LOUISVILLE ASSET BUILDING COALITION, INC. FOR PROGRAMMING EXPENSES ASSOCIATED WITH IMPLEMENTING THE VOLUNTEER INCOME TAX ASSISTANCE PROGRAM (VITA) (As Amended).

BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:

SECTION I: The sum of ~~\$5,000.04~~ \$10,750 \$15,250 is hereby appropriated from Neighborhood Development Funds in the following manner: ~~\$5,000.04~~ \$5,000 from District 14; \$1,000 each from Districts 13, 15, 12, 10, 24, 25; \$500 each from Districts 9, 16, 2, 3, 6, 7, 17; \$750 from District 8; through the Office of Management and Budget, to the Louisville Asset Building Coalition, Inc. for programming expenses associated with implementing the Volunteer Income Tax Assistance Program (VITA).

SECTION II: The Council has determined the funds requested in this Ordinance will be expended for a public purpose.

SECTION III: This grant is subject to the Council's Policies and Procedures as adopted and effective at the date of passage of this Ordinance.

SECTION IV: This Ordinance shall take effect upon its passage and approval.
