AN ORDINANCE APPROPRIATING ~~\$6,250~~\$2,500~~\$1,000~~ FROM NEIGHBORHOOD DEVELOPMENT FUNDS IN THE FOLLOWING MANNER: \$2,500 FROM DISTRICT 7; \$1,000 FROM DISTRICTS 7 AND 9; \$500 FROM DISTRICTS 8 AND 15; \$250 FROM DISTRICTS 10, 12 AND 13, 14, 17, 21, AND 22; THROUGH THE OFFICE OF MANAGEMENT AND BUDGET, TO TREESLOUISVILLE, INC. FOR PROGRAMMING EXPENSES ASSOCIATED WITH THE JEFFERSON COUNTY HIGH SCHOOL FRESHMAN 10,000 TREE GIVEAWAY (AS AMENDED).

BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE "COUNCIL") AS FOLLOWS:

SECTION I: The total of ~~\$6,250~~\$2,500~~\$1,000~~ is hereby appropriated from Neighborhood Development Funds in the following manner: \$2,500 from District 7; \$1,000 from Districts 7 and 9; \$500 from Districts 8 and 15; \$250 from Districts 10, 12 and 13, 14, 17, 21, and 22; through the Office of Management and Budget, to TreesLouisville, Inc. for programming expenses associated with the Jefferson County High School Freshman 10,000 Tree Giveaway.

SECTION II: The Council has determined the funds requested in this Ordinance will be expended for a public purpose.

SECTION III: This grant is subject to the Council's Policies and Procedures as adopted and effective at the date of passage of this Ordinance.

SECTION IV: This Ordinance shall take effect upon its passage and approval.
