ORDINANCE NO, SERIES 2014 AN ORDINANCE APPROPRIATING \$1,554 FROM DISTRICT 4 NEIGHBORHOOD DEVELOPMENT FUNDS AND AMENDING ORDINANCE NO. 39, SERIES 2014, ADOPTED BY THE LOUISVILLE METRO COUNCIL AT ITS REGULAR MEETING OF MARCH 13, 2014, WHEREBY AN APPROPRIATION OF \$12,250 FROM NEIGHBORHOOD DEVELOPMENT FUNDS WAS APPROVED AS FOLLOWS: \$5,000 FROM DISTRICT 21; \$2,000 FROM DISTRICT 12; \$1,500 EACH FROM DISTRICTS 13, 1; \$1,000 FROM DISTRICT 16 \$250 FROM DISTRICT 9; \$500 FROM DISTRICTS 8, 14; FOR A NEW TOTAL APPROPRIATION OF \$13,804; THROUGH THE OFFICE OF MANAGEMENT AND BUDGET, TO STAGE ONE: THE LOUISVILLE CHILDREN'S THEATRE, INC., FOR SUPPLEMENTAL SALARIES FOR ACTORS PERFORMING IN "THE GLORIOUS ADVENTURES OF THE MIGHTY ROBIN HOOD" AT THE KENTUCKY CENTER FOR THE ARTS. SPONSORED BY: Council Member Tandy
BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:
SECTION I: The sum of \$1,554 is hereby appropriated from District 4 Neighborhood Development Funds and
amending Ordinance No. 39, Series 2014, adopted by the Louisville Metro Council at its regular meeting of March 13,
2014, whereby an appropriation of \$12,250 from Neighborhood Development Funds was approved as follows: \$5,000
from District 21; \$2,000 from District 12; \$1,500 each from Districts 13, 1; \$1,000 from District 16; \$250 from District 9;
\$500 from Districts 8, 14; for a new total appropriation of \$13,804; through the Office of Management and Budget, to
Stage One: the Louisville Children's Theatre, Inc., for supplemental salaries for actors performing in "The Glorious
Adventures of the Mighty Robin Hood" at the Kentucky Center for the Arts.
SECTION II: The Council has determined the funds requested in this Ordinance will be expended for a public
purpose.
SECTION III: This grant is subject to the Council's Policies and Procedures, Section 3 as adopted by Resolution No.
290, Series 2011.
SECTION IV: This Ordinance shall take effect upon its passage and approval.
