ORDINANCE NO. _____, SERIES 2014

AN ORDINANCE APPROPRIATING \$1,554 FROM DISTRICT 4 NEIGHBORHOOD DEVELOPMENT FUNDS AND AMENDING ORDINANCE NO. 39, SERIES 2014, ADOPTED BY THE LOUISVILLE METRO COUNCIL AT ITS REGULAR MEETING OF MARCH 13, 2014, WHEREBY AN APPROPRIATION OF \$12,250 FROM NEIGHBORHOOD DEVELOPMENT FUNDS WAS APPROVED AS FOLLOWS: \$5,000 FROM DISTRICT 21; \$2,000 FROM DISTRICT 12; \$1,500 EACH FROM DISTRICTS 13, 1; \$1,000 FROM DISTRICT 16 \$250 FROM DISTRICT 9; \$500 FROM DISTRICTS 8, 14; FOR A NEW TOTAL APPROPRIATION OF \$13,804; THROUGH THE OFFICE OF MANAGEMENT AND BUDGET, TO STAGE ONE: THE LOUISVILLE CHILDREN’S THEATRE, INC., FOR SUPPLEMENTAL SALARIES FOR ACTORS PERFORMING IN “THE GLORIOUS ADVENTURES OF THE MIGHTY ROBIN HOOD” AT THE KENTUCKY CENTER FOR THE ARTS.

BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:

SECTION I: The sum of \$1,554 is hereby appropriated from District 4 Neighborhood Development Funds and amending Ordinance No. 39, Series 2014, adopted by the Louisville Metro Council at its regular meeting of March 13, 2014, whereby an appropriation of \$12,250 from Neighborhood Development Funds was approved as follows: \$5,000 from District 21; \$2,000 from District 12; \$1,500 each from Districts 13, 1; \$1,000 from District 16; \$250 from District 9; \$500 from Districts 8, 14; for a new total appropriation of \$13,804; through the Office of Management and Budget, to Stage One: the Louisville Children’s Theatre, Inc., for supplemental salaries for actors performing in “The Glorious Adventures of the Mighty Robin Hood” at the Kentucky Center for the Arts.

SECTION II: The Council has determined the funds requested in this Ordinance will be expended for a public purpose.

SECTION III: This grant is subject to the Council’s Policies and Procedures, Section 3 as adopted by Resolution No. 290, Series 2011.

SECTION IV: This Ordinance shall take effect upon its passage and approval.
