ORDINANCE NO. _____, SERIES 2017

AN ORDINANCE APPROPRIATING ~~\$23,500~~ \$25,500 \$30,000 FROM NEIGHBORHOOD DEVELOPMENT FUNDS BY ALLOCATING IN THE FOLLOWING MANNER: \$20,000 FROM DISTRICT 5; AND ~~\$3,500~~ \$5,000 FROM DISTRICT 4; AND \$500 EACH FROM DISTRICTS 1, 3, 6, 7, 9, 10, 12, AND 25; AND \$250 EACH FROM DISTRICTS 13, 14, 17, AND 24; THROUGH THE OFFICE OF MANAGEMENT AND BUDGET, TO NEIGHBORHOOD HOUSE, INC. FOR PROGRAMMING AND OPERATING EXPENSES ASSOCIATED WITH DREAMERS' ACADEMY 2017. (AS AMENDED).

BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:

SECTION I: The sum of ~~\$23,500~~ \$25,500 \$30,000 is hereby appropriated from Neighborhood Development Funds in the following manner: by allocating \$20,000 from District 5; and ~~\$3,500~~ \$5,000 from District 4; and \$500 each from Districts 1, 3, 6, 7, 9, 10, 12, and 25; and \$250 each from Districts 13, 14, 17, and 24; through the Office of Management and Budget, to Neighborhood House, Inc. for programming and operating expenses associated with conducting Dreamers' Academy 2017.

SECTION II: The Council has determined the funds requested in this Ordinance will be expended for a public purpose.

SECTION III: This grant is subject to the Council's Policies and Procedures as adopted and effective at the date of passage of this Ordinance.

SECTION IV: This Ordinance shall take effect upon its passage and approval.
