### ORDINANCE NO. \_\_\_\_\_, SERIES 2016

**AN ORDINANCE APPROPRIATING ~~\$5,000~~ \$7,750 ~~\$15,500~~ FROM NEIGHBORHOOD DEVELOPMENT FUNDS IN THE FOLLOWING MANNER: \$1,000 EACH FROM DISTRICTS 15, 9, 17, 21, 12, 4; \$2,000 FROM DISTRICT 26; \$1,500 FROM DISTRICT 8; AND \$500 EACH FROM DISTRICTS 13, 12, 1, 2, 3, 5, 6, 7, 10, 14, 16, 24, 25; AND \$250 FROM DISTRICT 10, THROUGH THE OFFICE OF MANAGEMENT AND BUDGET, TO THE AIDS SERVICES CENTER COALITION, INC. DBA THE LOUISVILLE AIDS WALK, FOR PROGRAMMING EXPENSES ASSOCIATED WITH THE 2016 LOUISVILLE AIDS WALK CAMPAIGN TO SUPPORT DIRECT CLIENT SERVICES. (AS AMENDED)**

**BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:**

**SECTION I:** The sum of ~~\$5,000~~ \$7,750 ~~\$15,500~~ is hereby appropriated from Neighborhood Development Funds in the following manner: \$1,000 each from Districts 15, 9, 17, 21, 12, 4; \$2,000 from District 26; \$1,500 from District 8; and \$500 each from Districts 13, 12, 1, 2, 3, 5, 6, 7, 10, 14, 16, 24, 25; and \$250 from District 10, through the Office of Management and Budget, to the AIDS Services Center Coalition, Inc. dba the Louisville AIDS Walk, for programming expenses associated with the 2016 Louisville AIDS Walk Campaign to support direct client services.

**SECTION II:** The Council has determined the funds requested in this Ordinance will be expended for a public purpose.

**SECTION III:** This grant is subject to the Council's Policies and Procedures as adopted and effective at the date of passage of this Ordinance.

**SECTION IV:** This Ordinance shall take effect upon its passage and approval.
