**ORDINANCE NO. \_\_\_\_\_, SERIES 2021**

**AN ORDINANCE APPROPRIATING ~~\$5,000~~ \$10,000 FROM DISTRICT 2 NEIGHBORHOOD DEVELOPMENT FUNDS IN THE FOLLOWING MANNER: \$5,000 FROM DISTRICT 2; \$500 EACH FROM DISTRICTS 8, 9, 10, 15, 17, 19, 20, AND 24; \$300 FROM DISTRICT 21; \$250 EACH FROM DISTRICTS 3 AND 25; AND \$200 FROM DISTRICT 7; THROUGH THE OFFICE OF MANAGEMENT AND BUDGET, TO THE AMERICAN RED CROSS LOUISVILLE AREA CHAPTER TO ASSIST WITH HOME FIRE AND DISASTER RELIEF (AS AMENDED).**

**BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE "COUNCIL") AS FOLLOWS:**

**SECTION I:** The sum of ~~\$5,000~~ \$10,000 from district 2 Neighborhood Development Funds in the following manner: \$5,000 from District 2; \$500 each from Districts 8, 9, 10, 15, 17, 19, 20, and 24; \$300 from District 21; \$250 each from Districts 3 and 25; and \$200 from District 7; through the Office of Management and Budget, to the American Red Cross Louisville Area Chapter to assist with home fire and disaster relief.

**SECTION II:** The Council has determined the funds requested in this Ordinance will be expended for a public purpose.

**SECTION III:** This grant is subject to the Council's Policies and Procedures as adopted and effective at the date of passage of this Ordinance.

**SECTION IV:** This Ordinance shall take effect upon its passage and approval.
