AN ORDINANCE APPROPRIATING ~~\$5,004~~ \$5,551 ~~\$7,601~~ FROM NEIGHBORHOOD DEVELOPMENT FUNDS, IN THE FOLLOWING MANNER: ~~\$2,504~~ \$2,025.50 EACH FROM DISTRICTS 9 AND 16; ~~\$2,500~~ FROM DISTRICT 16; \$500 from district 7, \$400 from District 20; \$350 from district 13; \$300 from district 8 and 14; \$250 from District 2, 6, 17, 21, 22 and 25; \$200 from District 10, THROUGH THE OFFICE OF MANAGEMENT AND BUDGET, TO ST. JOSEPH CATHOLIC ORPHAN SOCIETY DBA ST. JOSEPH CHILDREN'S HOME FOR SECURITY MEASURES FOR THE 167TH ST. JOE'S PICNIC FOR THE KIDS. (as amended)

BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:

SECTION I: The sum of ~~\$5,004~~ \$5,551 ~~\$7601~~ is hereby appropriated from Neighborhood Development Funds, in the following manner: ~~\$2,504~~ \$2,025.50 each from Districts 9 and 16; ~~\$2,500~~ from District 16; \$500 from District 7; \$400 from District 20; \$350 from District 13; \$300 from District 8 and 14; \$250 from District 2, 6, 17, 21, 22 and 25; \$200 from District 10 through the Office of Management and Budget, to St. Joseph Catholic Orphan Society dba St. Joseph Children's Home for security measures for the 167th St. Joe's Picnic for the Kids.

SECTION II: The Council has determined the funds requested in this Ordinance will be expended for a public purpose.

SECTION III: This grant is subject to the Council's Policies and Procedures as adopted and effective at the date of passage of this Ordinance.

SECTION IV: This Ordinance shall take effect upon its passage and approval.
