### ORDINANCE NO. \_\_\_\_\_, SERIES 2015

**AN ORDINANCE AMENDING ORDINANCE NO. 1 SERIES 2015, WHICH AMENDED ORDINANCE NO. 184, SERIES 2014 TO READ AS FOLLOWS: AN ORDINANCE APPROPRIATING \$7,250 FROM NEIGHBORHOOD DEVELOPMENT FUNDS IN THE FOLLOWING MANNER: \$1,000 EACH FROM DISTRICTS 13, 24; \$500 EACH FROM DISTRICTS 8, 21, 6, 1; \$250 EACH FROM DISTRICTS 16, 22, 17, 12, 10, 26, 9, 2, 3, 5, 14, 15, 25; THROUGH THE OFFICE OF MANAGEMENT AND BUDGET, TO THE COALITION FOR THE HOMELESS, INC. FOR PROGRAMMING EXPENSES ASSOCIATED WITH THE "GIVE-A-JAM" EVENT TO RAISE FUNDS FOR HOMELESS EDUCATION AND YOUTH PROGRAMS AND PROGRAMMING EXPENSES FOR THOSE PROGRAMS.**

**BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:**

**SECTION I:** An Ordinance amending Ordinance No. 1, Series 2015, which amended Ordinance No. 184, Series 2014 to read as follows: An Ordinance appropriating \$7,250 from Neighborhood Development Funds, in the following manner: \$1,000 each from Districts 13, 24; \$500 each from Districts 8, 21, 6, 1; \$250 each from Districts 16, 22, 17, 12, 10, 26, 9, 2, 3, 5, 14, 15, 25; through the Office of Management and Budget, to the Coalition for the Homeless, Inc., for programming expenses associated with the "Give-A-Jam" event to raise funds for homeless education and youth programs and programming expenses for those programs.

**SECTION II:** The Council has determined the funds requested in this Ordinance will be expended for a public purpose.

**SECTION III:** This grant is subject to the Council's Policies and Procedures as adopted and effective at the date of passage of this Ordinance.

**SECTION IV:** This Ordinance shall take effect upon its passage and approval.
