### ORDINANCE NO. \_\_\_\_\_, SERIES 2015

**AN ORDINANCE APPROPRIATING ~~\$5,750~~ \$6,250 \$6,500 FROM NEIGHBORHOOD DEVELOPMENT FUNDS IN THE FOLLOWING MANNER: \$1,500 FROM DISTRICTS 12, 5; \$750 FROM DISTRICT 1; \$500 FROM DISTRICTS 13, 14, 4, 25 \$250 EACH FROM DISTRICTS 10, 16, 17; TO METRO PARKS FOR COSTS ASSOCIATED WITH THE CANOEMOBILE EVENT TO BE HELD OCTOBER 1ST FOR JCPS ECHO SCHOOL; OCTOBER 2ND AT SHAWNEE PARK AND OCTOBER 3RD AT RIVERVIEW PARK (As Amended).**

**BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:**

**SECTION I:** The sum of ~~\$5,750~~ \$6,250 \$6,500 is hereby appropriated from Neighborhood Development Funds in the following manner: \$1,500 from Districts 12, 5; \$750 from District 1; \$500 from Districts 13, 14, 4, 25; \$250 each from Districts 10, 16, 17; to Metro Parks for costs associated with the Canoemobile event to be held October 1<sup>st</sup> for JCPS Echo School; October 2<sup>nd</sup> at Shawnee Park and October 3<sup>rd</sup> at Riverview Park.

**SECTION II:** The Council has determined that the funds requested in this Ordinance will be expended for a public purpose.

**SECTION III:** This grant is subject to the Council's Policies and Procedures as adopted and effective at the date of passage of this Ordinance.

**SECTION IV:** This Ordinance shall take effect upon its passage and approval.
