**AN ORDINANCE APPROPRIATING ~~\$5,001~~ \$12,000 \$17,000 FROM NEIGHBORHOOD DEVELOPMENT FUNDS AS FOLLOWS: ~~\$5,001~~ \$5,000 FROM DISTRICT 12; \$3,000 EACH FROM DISTRICTS 13, 14, 25; \$1,000 EACH FROM DISTRICTS 15, 24, \$500 EACH FROM DISTRICTS 3, 21; TO METRO PARKS FOR EXPENSES ASSOCIATED WITH THE 2016 RIVERVIEW PARK INDEPENDENCE FESTIVAL (As Amended).**

**BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:**

**SECTION I:** The sum of ~~\$5,001~~ \$12,000 \$17,000 is hereby appropriated from Neighborhood Development Funds as follows: ~~\$5,001~~ \$5,000 from District 12; \$3,000 each from Districts 13, 14, 25; \$1,000 each from Districts 15, 24; \$500 each from Districts 3, 21; to Metro Parks for expenses associated with the 2016 Riverview Park Independence Festival.

**SECTION II:** The Council has determined the funds requested in this Ordinance will be expended for a public purpose.

**SECTION III:** This grant is subject to the Council's Policies and Procedures as adopted and effective at the date of passage of this Ordinance.

**SECTION IV:** This Ordinance shall take effect upon its passage and approval.
