ORDINANCE NO, SERIES 2014  AN ORDINANCE APPROPRIATING \$8,520 \$15,220 \$18,870 FROM NEIGHBORHOOD DEVELOPMENT FUNDS IN THE FOLLOWING MANNER: \$2,870 \$2,520 FROM DISTRICT 10; \$1,000 EACH FROM DISTRICTS 5, 13, 15, 4, 16, 17, 7, 2, 3, 9; \$750 FROM DISTRICT 9; \$700 FROM DISTRICT 6; \$650 EACH FROM DISTRICTS 23, 1, 22 8, 14 18; \$250 FROM DISTRICT 19; \$500 FROM DISTRICTS 12, 20, 25; THROUGH THE OFFICE OF MANAGEMENT AND BUDGET, TO THIS START OF THE HEART FOUNDATION, INC. FOR TRAINING EQUIPMENT AND PROGRAM MATERIALS FOR A HANDS-ON CPR TRAINING PROGRAM (AMENICAL). BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:
SECTION I: The sum of \$8,520 \$15,220 \$18,870 is hereby appropriated from Neighborhood Development Funds in th
following manner: \$2,870 <u>\$2,520</u> from District 10; \$1,000 each from Districts 5, 13, 15 <u>, 4, 16, 17, 7, 2, 3, 9;</u> <u>\$750 from Districts 5</u> , 13, 15, 4, 16, 17, 7, 2, 3, 9;
District 9; \$700 from District 6; \$650 each from Districts 23, 1, 22, 8, 14, 18; \$250 from District 19; \$500 from Districts 12
20, 25; through the Office of Management and Budget, to the Start of the Heart Foundation, Inc. for training equipmer
and program materials for a hands-on CPR training program.
<b>SECTION II:</b> The Council has determined the funds requested in this Ordinance will be expended for a public purpose.
<b>SECTION III:</b> This grant is subject to the Council's Policies and Procedures as adopted and effective at the date of passage of this Ordinance.
SECTION IV: This Ordinance shall take effect upon its passage and approval.
