ORDINANCE NO. _____, SERIES 2021

AN ORDINANCE APPROPRIATING ~~\$4,500~~ \$12,750 \$20,500 FROM NEIGHBORHOOD DEVELOPMENT FUNDS IN THE FOLLOWING MANNER: \$4,000 EACH FROM DISTRICTS 4 AND 22; \$2,000 FROM DISTRICT 19; \$1,500 FROM DISTRICT 13; \$1,000 EACH FROM DISTRICTS 2, 4, 14, 15, AND 17, AND 19; \$750 FROM DISTRICT 21; \$500 EACH FROM DISTRICTS 1, 5, 6, 7, 24, AND 25 14, AND 21; AND \$250 EACH FROM DISTRICTS 9, 10, 12, 16, AND 20; THROUGH THE OFFICE OF MANAGEMENT AND BUDGET, TO JUNIOR ACHIEVEMENT OF KENTUCKIANA INC. TO PAY FOR EXTENSIVE ACTIVITY BASED CURRICULUM MATERIALS (AS AMENDED).

BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE "COUNCIL") AS FOLLOWS:

SECTION I: The sum of ~~\$4,500~~ \$12,750 \$20,500 from Neighborhood Development Funds in the following manner: \$4,000 each from Districts 4 and 22; \$2,000 from District 19; \$1,500 from District 13; \$1,000 each from Districts 2, 4, 14, 15, and 17, and 19; \$750 from District 21; \$500 each from Districts 1, 5, 6, 7, 24, and 25 14, and 21; and \$250 each from Districts 9, 10, 12, 16, and 20; through the Office of Management and Budget, to Junior Achievement of Kentuckiana Inc. to pay for extensive activity based curriculum materials.

SECTION II: The Council has determined the funds requested in this Ordinance will be expended for a public purpose.

SECTION III: This grant is subject to the Council's Policies and Procedures as adopted and effective at the date of passage of this Ordinance.

SECTION IV: This Ordinance shall take effect upon its passage and approval.
