BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:
SECTION I: The sum of \$9,605 is hereby appropriated from Neighborhood Development Funds in the following
manner: \$3,825 from District 4; \$395 each from Districts 14, 5, 15, 26, 10, 2, 6, 13, 21, 12, 3, 8, 23, 24; \$250 from District
25, through the Office of Management and Budget, to Actors Theatre of Louisville, Inc. for costs associated with the
production or a Community Conversation - "The Brothers Size" including postage, printing, promotion and ticket
subsidies.
SECTION II: The Council has determined the funds requested in this Ordinance will be expended for a public purpose.
SECTION III: This grant is subject to the Council's Policies and Procedures as adopted and effective at the date of
passage of this Ordinance.
