**ORDINANCE NO. \_\_\_\_\_, SERIES 2022**

**AN ORDINANCE APPROPRIATING ~~\$5,000~~ \$10,000 ~~\$15,000~~ FROM NEIGHBORHOOD DEVELOPMENT FUNDS IN THE FOLLOWING MANNER: \$5,000 FROM DISTRICT 8; AND \$1,000 EACH FROM DISTRICTS 2, 9, 10, 12, 13, 14, 16, AND 23, AND 24; AND \$500 EACH FROM DISTRICTS 7 AND 21, THROUGH THE OFFICE OF MANAGEMENT AND BUDGET, TO JEWISH COMMUNITY OF LOUISVILLE, INC. FOR CAPITAL EXPENSES TO BUILD A PUBLIC PLAYGROUND AT THE TRAGER FAMILY JEWISH COMMUNITY CENTER (AS AMENDED).**

**BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE "COUNCIL") AS FOLLOWS:**

**SECTION I:** The sum of ~~\$5,000~~ \$10,000 ~~\$15,000~~ is hereby appropriated from Neighborhood Development Funds in the following manner: \$5,000 from District 8; and \$1,000 each from Districts 2, 9, 10, 12, 13, 14, 16, and 23, and 24; and \$500 each from Districts 7 and 21, through the Office of Management and Budget, to Jewish Community of Louisville, Inc. for capital expenses to build a public playground at the Trager Family Jewish Community Center.

**SECTION II:** The Council has determined the funds requested in this Ordinance will be expended for a public purpose.

**SECTION III:** This grant is subject to the Council's Policies and Procedures as adopted and effective at the date of passage of this Ordinance.

**SECTION IV:** This Ordinance shall take effect upon its passage and approval or otherwise becoming law.
