### ORDINANCE NO. \_\_\_\_\_, SERIES 2016

AN ORDINANCE APPROPRIATING A TOTAL OF ~~\$35,035.72~~ \$13,250 \$14,750 FROM DISTRICT 8 NEIGHBORHOOD DEVELOPMENT FUNDS (NDF) AS FOLLOWS: \$5,000 FROM DISTRICT 8; \$1,500 FROM DISTRICT 21; \$1,000 EACH FROM DISTRICTS 4, 6, 9 AND 12; \$500 EACH FROM DISTRICTS 1, 2, 10, 13, 15, 25 AND 26; AND \$250 EACH FROM DISTRICTS 3, 5, AND 14, THROUGH THE OFFICE OF MANAGEMENT AND BUDGET TO LOUISVILLE PRIDE FOUNDATION, INC. FOR ITS SECOND ANNUAL LOUISVILLE PRIDE FESTIVAL ON BARDSTOWN ROAD. (AS AMENDED)

**BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:**

**SECTION I:** The total amount of ~~\$35,035.72~~ \$13,250 \$14,750 is hereby appropriated from Neighborhood Development Funds (NDF) as follows: \$5,000 from District 8; \$1,500 from District 21; \$1,000 each from Districts 4, 6, 9 and 12; \$500 each from Districts 1, 2, 10, 13, 15, 25 and 26; and \$250 each from Districts 3, 5, and 14, through the Office of Management and Budget to Louisville Pride Foundation, Inc. for its second annual Louisville Pride Festival on Sept. 17, 2016 at the 1000-1200 blocks of Bardstown Road. The event is open to the public and will be the second annual festival at this location. The Louisville Pride Festival event engages the broader community about conversations and celebration of our local LGBTQ community.

**SECTION II:** The Council has determined that the funds requested in this Ordinance will be expended for a public purpose.

**SECTION III:** This Ordinance shall take effect upon its passage and approval.
