### ORDINANCE NO. \_\_\_\_\_, SERIES 2020

**AN ORDINANCE APPROPRIATING ~~\$11,500~~ \$14,000 FROM NEIGHBORHOOD DEVELOPMENT FUNDS IN THE FOLLOWING MANNER: \$1,500 FROM DISTRICT 4; \$1,000 EACH FROM DISTRICTS 9, 12, 13, 14, AND 24; \$750 FROM DISTRICT 1; \$500 EACH FROM DISTRICTS 4, 2, 6, 8, 10, 15, 17, 19, 20, 21, 22, 23, AND 25; \$250 EACH FROM DISTRICTS 3, AND 5, AND 7; THROUGH THE OFFICE OF MANAGEMENT AND BUDGET, TO THE COALITION FOR THE HOMELESS, INC. FOR PROGRAMMING EXPENSES ASSOCIATED WITH PROJECT STAND DOWN (AS AMENDED).**

**BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT ("THE COUNCIL") AS FOLLOWS:**

**SECTION I:** The sum of ~~\$11,500~~ \$14,000 is hereby appropriated from Neighborhood Development Funds in the following manner: \$1,500 from District 4; \$1,000 each from Districts 9, 12, 13, 14, and 24; \$750 from District 1; \$500 each from Districts 4, 2, 6, 8, 10, 15, 17, 19, 20, 21, 22, 23, and 25; \$250 each from Districts 3, and 5, and 7; through the Office of Management and Budget, to the Coalition for the Homeless, Inc. for programming expenses associated with Project Stand Down.

**SECTION II:** The Council has determined the funds requested in this Ordinance will be expended for a public purpose.

**SECTION III:** This grant is subject to the Council's Policies and Procedures as adopted and effective at the date of passage of this Ordinance.

**SECTION IV:** This Ordinance shall take effect upon its passage and approval.
