AN ORDINANCE APPROPRIATING ~~\$9,700~~ \$13,000 FROM NEIGHBORHOOD DEVELOPMENT FUNDS IN THE FOLLOWING MANNER: ~~\$3,500~~ \$5,000 FROM DISTRICT 4; ~~\$1,500~~ \$1,550 FROM DISTRICT 3; \$1,000 EACH FROM DISTRICTS 1 AND 20; \$750 FROM DISTRICT 6; \$500 EACH FROM DISTRICTS 5, 21, AND 22; \$250 EACH FROM DISTRICTS 2, 9, 10, 13, 15, 17, 24, AND 26; AND \$200 FROM DISTRICT 7; THROUGH THE OFFICE OF MANAGEMENT AND BUDGET, TO SOWING SEEDS WITH FAITH INC FOR COSTS ASSOCIATED WITH THE SOWING SEEDS WITH FAITH ACADEMIC ENRICHMENT SUMMER CAMP (AS AMENDED).

**BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:**

**SECTION I:** The sum of ~~\$9,700~~ \$13,000 is hereby appropriated from Neighborhood Development Funds in the following manner: ~~\$3,500~~ \$5,000 from District 4; ~~\$1,500~~ \$1,550 from District 3; \$1,000 each from Districts 1 and 20; \$750 from District 6; \$500 each from Districts 5, 21, and 22; \$250 each from Districts 2, 9, 10, 13, 15, 17, 24, and 26; and \$200 from District 7; through the Office of Management and Budget, to Sowing Seeds With Faith Inc. for costs associated with the Sowing Seeds with Faith Academic Enrichment Summer Camp.

**SECTION II:** The Council has determined the funds requested in this Ordinance will be expended for a public purpose.

**SECTION III:** This grant is subject to the Council's Policies and Procedures as adopted and effective at the date of passage of this Ordinance.

**SECTION IV:** This Ordinance shall take effect upon its passage and approval.
