AN ORDINANCE APPROPRIATING ~~\$9,700~~ \$13,000 FROM NEIGHBORHOOD DEVELOPMENT FUNDS IN THE FOLLOWING MANNER: ~~\$3,500~~ \$5,000 FROM DISTRICT 4; ~~\$1,500~~ \$1,550 FROM DISTRICT 3; \$1,000 EACH FROM DISTRICTS 1 AND 20; \$750 FROM DISTRICT 6; \$500 EACH FROM DISTRICTS 5, 21, AND 22; \$250 EACH FROM DISTRICTS 2, 9, 10, 13, 15, 17, 24, AND 26; AND \$200 FROM DISTRICT 7; THROUGH THE OFFICE OF MANAGEMENT AND BUDGET, TO SOWING SEEDS WITH FAITH INC FOR COSTS ASSOCIATED WITH THE SOWING SEEDS WITH FAITH ACADEMIC ENRICHMENT SUMMER CAMP (AS AMENDED).

BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:

SECTION I: The sum of ~~\$9,700~~ \$13,000 is hereby appropriated from Neighborhood Development Funds in the following manner: ~~\$3,500~~ \$5,000 from District 4; ~~\$1,500~~ \$1,550 from District 3; \$1,000 each from Districts 1 and 20; \$750 from District 6; \$500 each from Districts 5, 21, and 22; \$250 each from Districts 2, 9, 10, 13, 15, 17, 24, and 26; and \$200 from District 7; through the Office of Management and Budget, to Sowing Seeds With Faith Inc. for costs associated with the Sowing Seeds with Faith Academic Enrichment Summer Camp.

SECTION II: The Council has determined the funds requested in this Ordinance will be expended for a public purpose.

SECTION III: This grant is subject to the Council's Policies and Procedures as adopted and effective at the date of passage of this Ordinance.

SECTION IV: This Ordinance shall take effect upon its passage and approval.
