**ORDINANCE NO. \_\_\_\_\_, SERIES 2016**

**AN ORDINANCE APPROPRIATING A TOTAL OF ~~\$7,500~~ \$10,500 FROM NEIGHBORHOOD DEVELOPMENT FUNDS IN THE FOLLOWING MANNER: \$1,500 EACH FROM DISTRICTS 13, 12, 25, 21, 14, 1 AND 15; THROUGH THE OFFICE OF MANAGEMENT AND BUDGET, TO LOUISVILLE INDEPENDENT BUSINESS ALLIANCE, INC. FOR PROGRAM AND OPERATING EXPENSES ASSOCIATED WITH THE SOUTH POINTS BUY LOCAL FAIR AND THE KEEP SOUTH LOUISVILLE WEIRD PROGRAM. (AS AMENDED)**

**BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:**

**SECTION I:** The total of ~~\$7,500~~ \$10,500 is hereby appropriated from Neighborhood Development Funds in the following manner: \$1,500 each from Districts 13, 12, 25, 21, 14, 1 and 15; through the Office of Management and Budget, to Louisville Independent Business Alliance, Inc. for program and operating expenses associated with the South Points Buy Local Fair and the Keep South Louisville Weird Program.

**SECTION II:** The Council has determined the funds requested in this Ordinance will be expended for a public purpose.

**SECTION III:** This grant is subject to the Council's Policies and Procedures as adopted and effective at the date of passage of this Ordinance.

**SECTION IV:** This Ordinance shall take effect upon its passage and approval.
