**BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:**

**SECTION I:** The sum of ~~\$6,100~~ \$6,500 is hereby appropriated from Neighborhood Development Funds in the following manner: \$2,000 from District 9; \$1,200 from District 8; \$1,000 from District 4; \$500 from District 10; \$300 each from Districts 15, 21, 25; \$200 from Districts 13, 16; \$100 each from Districts 20, 12, 1, 5, 23; through the Office of Management and Budget, to the Louisville Independent Business Alliance for programming costs of the Sixth Annual Buy Local Fair 2014.

**SECTION II:** The Council has determined the funds requested in this Ordinance will be expended for a public purpose.

**SECTION III:** This grant is subject to the Council's Policies and Procedures, Section 3, as adopted by Resolution No. 290, Series 2011.

**SECTION IV:** This Ordinance shall take effect upon its passage and approval.
