AN ORDINANCE AMENDING ORDINANCE NO. 107, SERIES 2013 PERTAINING TO THE 2013-2014 CAPITAL BUDGET, BY ESTABLISHING A NEW PROJECT TITLED RAILROAD CROSSING / ROAD CLOSURES - NORFOLK SOUTHERN RAILROAD.

Be it ordained by the Legislative Council of the Louisville/Jefferson County Metro Government (The Council) As Follows:

SECTION I: Part I. J. Public Works & Assets of Ordinance No. 107, Series 2013 is hereby amended as follows:

SECTION II: Louisville Metro Government and Commonwealth of Kentucky Transportation Cabinet both wish to enter into an agreement to move forward with the agreement for Railroad Crossing/Road Closures - Norfolk Southern Railroad as listed in Section I of this Ordinance. This Ordinance fulfills the Resolution requirement from the Commonwealth of Kentucky Transportation Cabinet by further recognizing the authority granted by KRS 67C.105(5)(h) for the Mayor to enter into this agreement.

SECTION III: The Council has determined that the funds requested in this ordinance will be expended for a public purpose.

SECTION IV: This Ordinance shall take effect upon its passage and approval.
