Be it ordained by the Legislative Council of the Louisville/Jefferson County Metro Government (The Council) As Follows:

SECTION I: Part I., A., 2. Louisville Metro Council, of Ordinance No. 106, Series 2013, is hereby amended as follows:

2. LOUISVILLE METRO COUNCIL

- a. General Operations General Fund ~~5,780,700~~ 5,785,700
- b. Neighborhood Development Fund General Fund ~~1,950,000~~ 1,945,000

SECTION II: The Council has determined the funds requested in this ordinance will be expended for a public purpose.

SECTION III: This Ordinance shall take effect upon its passage and approval.
