BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:

SECTION I: The sum of \$16,000 is hereby appropriated from Neighborhood Development Funds in the following manner: ~~\$7,000~~ \$5,500 from District 3; \$2,500 from District 4; \$2,000 from District 6; \$1,500 from District 5; \$1,000 from District 2; \$500 each from Districts 12, 9, 1, 8, 10, 24; \$250 each from Districts 14, 13; through the Office of Management

and Budget, to the West Jefferson County Community Task Force, Inc. for the continuation of the toxic air monitoring analysis program.

SECTION II: The Council has determined the funds requested in this Ordinance will be expended for a public purpose.

SECTION III: This grant is subject to the Council's Policies and Procedures as adopted and effective at the date of passage of this Ordinance.

SECTION IV: This Ordinance shall take effect upon its passage and approval.
