**BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:**

**SECTION I:** The sum of ~~\$8,000~~ \$8,250 is hereby appropriated from Neighborhood Development Funds, in the following manner: \$2,000 each from Districts 4, 5, 21; \$1,500 from District 1; \$500 from District 6; \$250 from District 2; through the Office of Management and Budget, to New Roots, Inc., for the Fresh Stop Project bringing fresh produce in otherwise

food desert areas, which includes the cost of a refrigerated box truck, telephone fees, copies of Fresh Stop advertising materials and other operational expenses.

**SECTION II:** The Council has determined the funds requested in this Ordinance will be expended for a public purpose.

**SECTION III:** This grant is subject to the Council's Policies and Procedures as adopted and effective at the date of passage of this Ordinance.

**SECTION IV:** This Ordinance shall take effect upon its passage and approval.
