BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:

SECTION I: The sum of \$77,500 \$95,500 is hereby appropriated from the Neighborhood Development Funds in the
following manner: \$10,000 each from Districts 16, 12, 4, 1; \$5,000 each from Districts 13, 21, 8, 6, 11 <u>, 17;</u> \$2,500 each
from Districts 9, 18, 7 <u>, 19, 20;</u> \$2,000 <u>each from Districts</u> 2 <u>, 14, 24; \$1,500 from District 5;</u> \$1,000 each from Districts 1
3, 10 <u>, 22, 23; \$500 from District 25;</u> through the Office of Management and Budget, to the Center for Women an
Families, Inc., for a roof replacement at the Joan e. Thomas (JET) facility.
SECTION II: The Council has determined the funds requested in this Ordinance will be expended for a public purpose.
SECTION III: This grant is subject to the Council's Policies and Procedures as adopted and effective at the date
