**BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:**

**SECTION I:** The sum of ~~\$5,005~~ \$6,305 is hereby appropriated from Neighborhood Development Funds in the following manner: \$1,555 from District 15; \$1,500 from District 1; \$1,000 from District 14; \$500 each from Districts 13, 6, 8; \$250 from District 16; ~~\$200~~ \$500 from District 10; through the Office of Management and Budget, to the Food Literacy Project at Oxmoor Farm, Inc., for capital equipment including computers, floor tiles, dry erase boards and new donor software.

**SECTION II:** The Council has determined the funds requested in this Ordinance will be expended for a public purpose.

**SECTION III:** This grant is subject to the Council's Policies and Procedures as adopted and effective at the date of passage of this Ordinance.

**SECTION IV:** This Ordinance shall take effect upon its passage and approval.
