## BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:

**SECTION I:** An Ordinance amending Ordinance No. 1, Series 2015, which amended Ordinance No.

184, Series 2014 to read as follows: An Ordinance appropriating \$7,250 from Neighborhood
