AN ORDINANCE APPROPRIATING \$5,000.01 \$10,750 \$15,250 FROM DISTRICT NEIGHBORHOOD DEVELOPMENT FUNDS AS FOLLOWS: \$5,000.01 \$5,000 FROM DISTRICT 14; \$1,000 EACH FROM DISTRICTS 13, 15, 12, 10; 24, 25; \$500 EACH FROM DISTRICTS 9, 16 2, 3, 6, 7, 17; \$750 FROM DISTRICT 8; THROUGH THE OFFICE OF MANAGEMENT AND BUDGET, TO THE LOUISVILLE ASSET BUILDING COALITION, INC. FOR PROGRAMMING EXPENSES ASSOCIATED WITH IMPLEMENTING THE VOLUNTEER INCOME TAX ASSISTANCE PROGRAM (VITA) (As Amended).

## BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:

SECTION I: The sum of \$5,000.01 \$10,750 \$15,250 is hereby appropriated from Neighborhood

Pass

Development Funds in the following manner: \$5,000.01 \$5,000 from District 14; \$1,000 each from Districts 13, 15, 12, 10, 24, 25; \$500 each from Districts 9, 16, 2, 3, 6, 7, 17; \$750 from District 8; through the Office of Management and Budget, to the Louisville Asset Building Coalition, Inc. for programming expenses associated with implementing the Volunteer Income Tax Assistance Program (VITA).

**SECTION II:** The Council has determined the funds requested in this Ordinance will be expended for a public purpose.

**SECTION III:** This grant is subject to the Council's Policies and Procedures as adopted and effective

at the date of passage of this Ordinance.

SECTION IV: This Ordinance shall take effect upon its passage and approval.
