BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:

SECTION I: The sum of \$8,630 \$10,130 is hereby appropriated from Neighborhood Development Funds, in the following manner: \$3,000 \$3,500 from District 21; \$1,500 from District 8; \$580 from District 1; \$500 each from Districts 9, 15, 10, 6; 26; 4, 12, 25; \$300 from District 3; \$250 from District 2; through the Office of Management and Budget, to Kentuckiana Pride Foundation, Inc., for costs associated with the Kentuckiana Pride Parade and Festival.
