HOURS, CONDITIONS, WORKING **BENEFITS** AND OTHER TERMS AND CONDITIONS OF EMPLOYMENT **BETWEEN** LOUISVILLE/JEFFERSON METRO GOVERNMENT AND THE AMERICAN FEDERATION OF STATE, COUNTY AND MUNICIPAL EMPLOYEES, AFL-CIO, LOCAL 2629 CONCERNING CIVILIAN SUPERVISORY **EMPLOYEES** OF THE **LOUISVILLE METRO CORRECTIONS** DEPARTMENT.

WHEREAS, a Collective Bargaining Agreement has been reached between Louisville/Jefferson County Metro Government and the American Federation of State, County and Municipal Employees, AFL-CIO, Local 2629 concerning civilian supervisory employees of the Louisville Metro Corrections Department.

SECTION I: The Collective Bargaining Agreement (August 13, 2015 - June 30, 2018) reached between Louisville/Jefferson County Metro Government and the American Federation of State, County and Municipal Employees, AFL-CIO, Local 2629 on behalf of civilian supervisory employees of the Louisville Metro Corrections Department concerning wages, hours, working conditions, benefits and other terms and conditions of employment and other matters, be and the same is hereby approved.
