AN ORDINANCE APPROPRIATING \$25,000 FROM NEIGHBORHOOD DEVELOPMENT FUNDS AS FOLLOWS: \$7,500 EACH FROM DISTRICTS 15, 21; \$5,000 FROM DISTRICT 12; \$1,000 EACH FROM DISTRICTS 24, 13, 25, 14; \$500 EACH FROM DISTRICTS 6, 2; TO LOUISVILLE METRO PARKS DEPARTMENT, FOR SECURITY CAMERAS, PATHWAYS AND OTHER COSTS ASSOCIATED WITH THE RENOVATION OF THE NORTH OVERLOOK AT IROQUOIS PARK.

BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:

SECTION I: The sum of \$25,000 is hereby appropriated from Neighborhood Development Funds as follows: \$7,500 each from Districts 15, 21; \$5,000 from District 12; \$1,000 each from Districts 24, 13, 25, 14; \$500 each from Districts 6, 2; to Louisville Metro Parks Department, for security cameras, pathways and other costs associated with the renovation of the north overlook at Iroquois Park.

SECTION II: The Council has determined the funds requested in this Ordinance will be expended for a public purpose.

SECTION III: This grant is subject to the Council's Policies and Procedures as adopted and effective

at the date of passage of this Ordinance.

SECTION IV: This Ordinance shall take effect upon its passage and approval.
