## BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:

**SECTION I:** The sum of \$25,000 is hereby appropriated from Neighborhood Development Funds as follows: \$7,500 each from Districts 15, 21; \$5,000 from District 12; \$1,000 each from Districts 24, 13, 25, 14; \$500 each from Districts 6, 2; to Louisville Metro Parks Department, for security cameras, pathways and other costs associated with the renovation of the north overlook at Iroquois Park.

**SECTION II:** The Council has determined the funds requested in this Ordinance will be expended for a public purpose.
