BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:

SECTION I: The sum of \$12,500 \$13,000 \$18,000 is hereby appropriated from Neighborhood

Development Funds in the following manner: \$2,000 from District 15; \$1,500 District 2; \$1,000 each					
from Districts 12, 13, 14, 21, 25, 10, 24, 9, 8, 4, 16; and \$500 each from Districts 5, 6, 11, 17, 22;					
\$250 each from Districts 3, 7, 18, 20; to Develop Louisville for expenses associated with the creation					
and placement of a "Mother Catherine Spalding" statue at the Cathedral of the Assumption.					
SECTION II: The Council has determined the funds requested in this Ordinance will be expended for					
a public purpose.					
SECTION III: This grant is subject to the Council's Policies and Procedures as adopted and effective					
at the date of passage of this Ordinance.					
SECTION IV: This Ordinance shall take effect upon its passage and approval.
