AN ORDINANCE APPROPRIATING **\$58.000** \$59.000 FROM NEIGHBORHOOD DEVELOPMENT FUNDS IN THE FOLLOWING MANNER: \$5,000 EACH FROM DISTRICTS 13, 2, 4, 5, 24; \$10,000 FROM DISTRICT 1, \$5,500 FROM DISTRICT 3; \$4,500 FROM DISTRICT 6; \$4,000 FROM DISTRICTS 15, 21; \$3,000 FROM DISTRICT 12; \$2,000 FROM DISTRICT 17; \$1,000 FROM DISTRICT 10; THROUGH THE OFFICE OF MANAGEMENT AND BUDGET, TO THE CENTER FOR ACCESSIBLE LIVING, INC. FOR MATERIALS TO CONSTRUCT WHEELCHAIR ACCESSIBLE RAMPS, STAIR RAILINGS AND GRAB BARS (As Amended).

BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:

SECTION I: The sum of \$58,000 \$59,000 is hereby appropriated from Neighborhood Development Funds in the

following manner: \$5,000 each from Districts 13, 2, 4, 5, 24; \$10,000 from District 1, \$5,500 from District 3; \$4,500 from

District 6; \$4,000 from Districts 15, 21; \$3,000 from District 12; \$2,000 from District 17; <u>\$1,000 from District 10;</u> through

the Office of Management and Budget, to the Center for Accessible Living, Inc. for materials to construct wheelchair accessible ramps, stair railings and grab bars.

SECTION II: The Council has determined the funds requested in this Ordinance will be expended for a public purpose.

SECTION III: This grant is subject to the Council's Policies and Procedures as adopted and effective at the date of passage of this Ordinance.

SECTION IV: This Ordinance shall take effect upon its passage and approval.
