BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:
SECTION I: The sum of \$5,001 \$10,000 is hereby appropriated from the District 10 Neighborhood Development Funds
in the following manner: \$4,750 \$750 from District 10; \$2,000 from District 20; \$1,000 each from Districts 4, 12, 20, 25;
\$500 each from Districts 5, 16, 21, 22, 24; \$250 each from Districts 7, 2, 3, 8, 13, 15, 23;, through the Office of
Management and Budget, to the Catholic Charities of Louisville, Inc. for costs associated with the Louisville Metro Human
Trafficking Summit.
SECTION II: The Council has determined the funds requested in this Ordinance will be expended for a public purpose.
SECTION III: This grant is subject to the Council's Policies and Procedures as adopted and effective at the date of
passage of this Ordinance.
SECTION IV: This Ordinance shall take effect upon its passage and approval.
