# BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:

SECTION I: The sum of \$46,000 is hereby appropriated from Neighborhood Development Funds in the following

manner: \$28,000 from District 23; \$12,000 from District 24; \$6,000 from District 13; to Metro Parks for a summer concert

series (FridayFest) in Highview Park for 2015-16 seasons.

SECTION II: The Council has determined that the funds requested in this Ordinance will be expended for a public

purpose.

SECTION III: This grant is subject to the Council's Policies and Procedures as adopted and effective at the date of

passage of this Ordinance.

**SECTION IV:** This Ordinance shall take effect upon its passage and approval.
