**BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:**

**SECTION I:** The sum of ~~\$5,004~~ \$23,001 ~~\$25,000~~ \$34,250 is hereby appropriated from the ~~District 7~~ Neighborhood Development Funds in the following manner: \$5,0001 from District 7; \$2,000 each from Districts 12, 13, 16, 17, 20, 22, 24, 25; \$1,500 \$2,500 from District 15; \$1,000 each from Districts 6, 9, 10, 11, 2, 4, 19, 23; \$500 from Districts 5 10, 1, 8, 18, 21; \$250 from District 3; through the Office of Management and Budget, to Jewish Hospital & St. Mary's Foundation for the purchase of a fully equipped mobile cancer screening van. for first year operating/program expenses including educational supplies and diagnostic screening kits and monitors

**SECTION II:** The Council has determined the funds requested in this Ordinance will be expended for a public purpose.

**SECTION III:** This grant is subject to the Council's Policies and Procedures as adopted and effective at the date of passage of this Ordinance.

**SECTION IV:** This Ordinance shall take effect upon its passage and approval.
