BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:

SECTION I: The sum of \$29,500 \$35,500 \$51,000 from Neighborhood Development

Funds in the following manner: \$10,500 from District 12; \$7,000 \$7,500 from District 23; \$6,000 from Districts 5, 12, 2; \$4,500 each from Districts 4, 12, 11, 3; \$3,000 each from Districts 11, 21, 17; \$1,500 from District 10; through the Office of Management and Budget, to Walden Theatre Corporation, for programming expenses associated with performances by the Blue Apple Players in local schools.

SECTION II: The Council has determined the funds requested in this Ordinance will be expended for a public purpose.

SECTION III: This grant is subject to the Council's Policies and Procedures as adopted and effective at the date of passage of this Ordinance.

SECTION IV: This Ordinance shall take effect upon its passage and approval.
