ORDINANCE NO. **SERIES 2015**

AN ORDINANCE APPROPRIATING \$10,000 FROM DISTRICT 17 NEIGHBORHOOD MANAGEMENT OFFICE DEVELOPMENT FUNDS. THROUGH THE OF AND BUDGET, TO THE CITY OF ROLLING HILLS, PURSUANT TO LMCO 97.100 ESTABLISHING A METRO PARTNERSHIP PROGRAM WITH SUBURBAN CITIES, FOR ADA COMPLIANT SIDEWALK IMPROVEMENTS AT SIX INTERSECTIONS. SPONSORED BY: Council Member Stuckel

BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO **GOVERNMENT (THE COUNCIL) AS FOLLOWS:**

SECTION I: The sum of \$10,000 is hereby appropriated from the District 17 Neighborhood Development Funds,

through the Office of Management and Budget, to the City of Rolling Hills, pursuant to LMCO 97.100 establishing a Metro

Partnership Program with Suburban Cities, for ADA compliant sidewalk improvements at six intersections.

SECTION II: The Council has determined the funds requested in this Ordinance will be expended for a public purpose.

SECTION III: This grant is subject to the Council's Policies and Procedures as adopted and effective at the date of

passage of this Ordinance.

SECTION IV: This Ordinance shall take effect upon its passage and approval.
